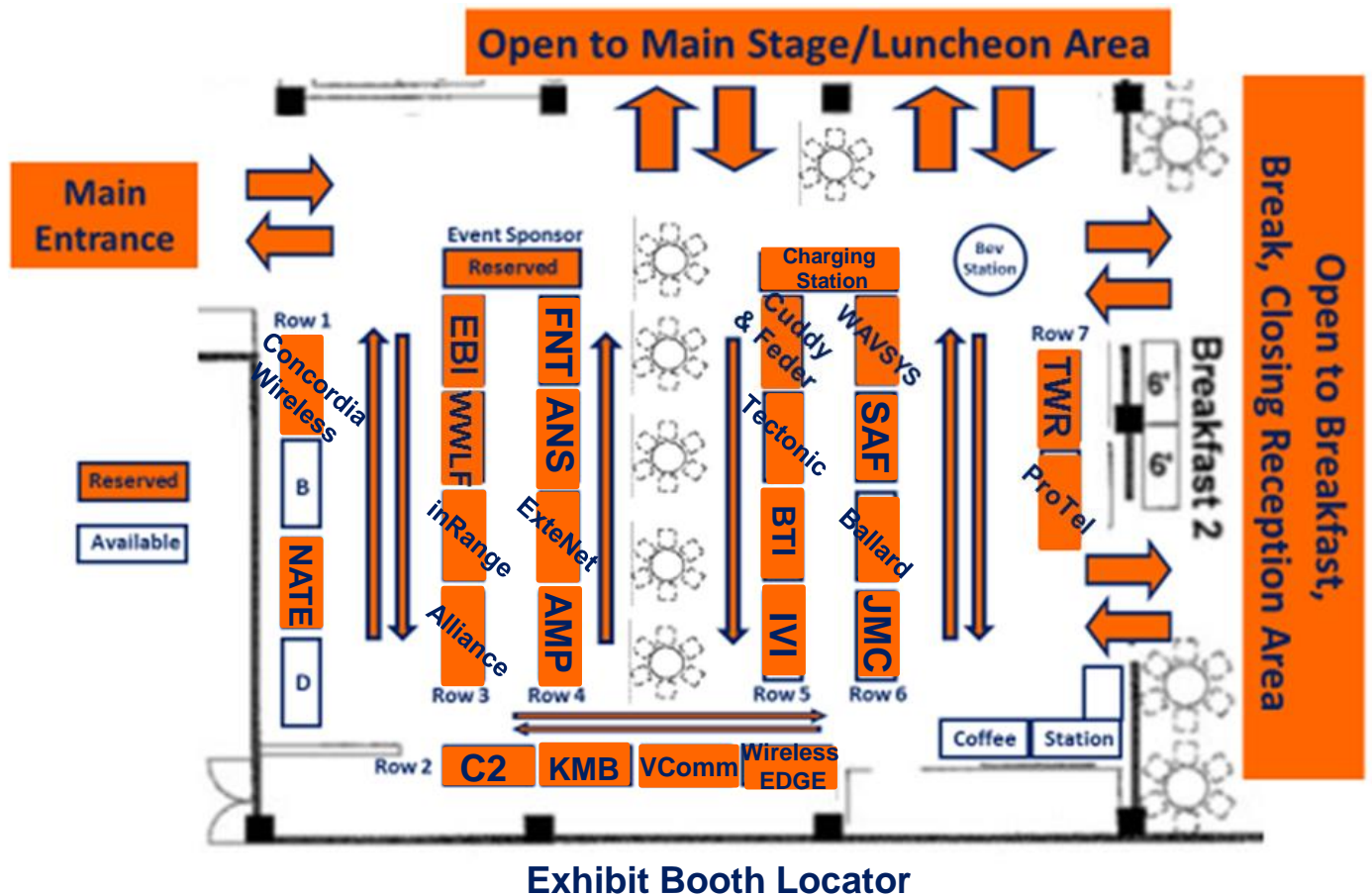
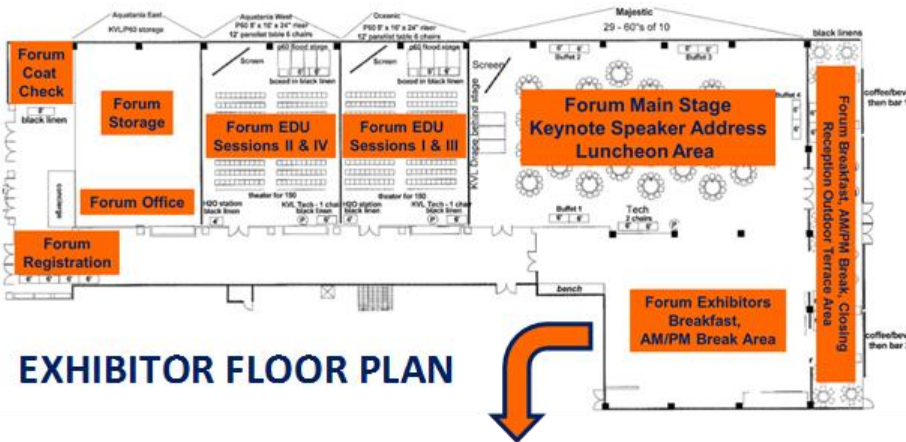
#### ***Additional Exhibitor Logistics***

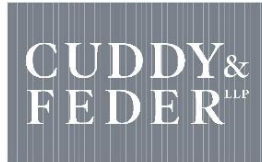
